On June 10, 2020, the Arizona Corporation Commission approved a rate increase requested by Ponderosa Utility Corporation. Per Decision No. 77661, the new rates become effective July 1, 2020.

The recently approved rates will increase the typical residential bill for a 5/8 x 3/4-inch meter, with a median usage of 2,278 gallons per month from \$32.11 to \$37.77, for an increase of \$5.66 or 17.63 percent.
